Kensington-Rockville Members Participate in AAUW Maryland Summer Leadership Conference

Here is a one person summary of the 2017 AAUW Maryland Summer Leadership Conference held in Frederick Maryland on July 29. The theme was "Actions to Bold, Effective Leadership." Besides gracious hosts, the meeting brought some interesting speakers and greeters. Jan Gardner, the Frederick County Executive Director had really

done her homework about AAUW and was an engaging greeter. I was happy to see a smart, dynamic woman serving as County Executive. We hope that Frederick AAUW branch recruits her to AAUW!

Eileen Menton provided a brief but effective strategic plan update and an overview of AAUW Maryland's successes with national leadership, fundraising, support for the national and state advocacy and lobby days, the Women of Distinction Award (Cleopatra Campbell fund in 2017) and recognition of AAUW Maryland and branches at national Convention. We may not be a big state but our generosity and accomplishments are great and we certainly know how to demonstrate "effective, bold leadership"!

The main speaker was Kimberly Churches, the new CEO of AAUW Maryland. She was an engaging, energetic speaker, and challenged those present to look at what AAUW is and where we should be headed. Some of the issues she discussed were a bit controversial and certainly thought provoking such as: Would it strengthen AAUW to become a non-membership organization? and Should we allocate our resources in very different ways? She made it clear that it is very important for the CEO and national office to hear from AAUW members

and branches. Members took the opportunity to tell our new CEO about what has remained vitally important for 136 years. In addition, as a gerontologist, I do have some concern about the way our organization was described as "aging" in terms of average age of branch membership. From my point of view, while we don't want to become moribund, what's so bad about actively recruiting middle aged and older women to AAUW branches? It is clear that AAUW needs to learn how to recruit and engage a diverse group of branch and online members to remain vital. But my take on our "aging" Maryland members is that we are a smart, creative, generous, well-traveled and well-read group of people who helped make AAUW Maryland's 2016-2017 Strategic Plan a success!

In addition to food for thought about who we are and where we should be headed, our state officers lead break-out sessions for attendees to prepare for the coming year. Of the six sessions, two were directed by Kensington-Rockville Branch presidents-- Kate Campbell Stevenson VP for Program and Erin Prangley VP for Public Policy. They were terrific!

As a final note, the Business Meeting included discussion and information about increasing Maryland's online community, supporting the 2018 Women of Distinction at NCCWSL, enhancing strategic public policy coalition partnerships, a 2018 Lobby Day in Annapolis, and enhanced action and communication technologies.

AAUW Maryland voted to continue support for a platinum sponsorship of the 2018 AAUW National Conference for College Women Student Leaders (NCCWSL) Women of Distinction Ceremony. Branches will be asked to raise funds to support NCCWSL at this high level. We will again have a Maryland Woman of Distinction Award, and everyone is encouraged to submit nominations no later than October 1 to Bea Dane at bea_dane@comcast.net. A vote to select the Maryland Woman of Distinction Award will take place at the October 21 board meeting.

The Maryland board also agreed to support two state bills sponsored by branches - A bill to extend child support for post-secondary education (Howard County) and the Maryland Patients' Bill of Rights (Kensington-Rockville). AAUW Maryland will also work coalition with the Maryland Legislative Agenda for Women (MLAW); Fight for \$15 (minimum wage); and Fair Scheduling Coalition to advance statewide public policy priorities.

The statewide meetings are a great place to learn more about what other

branches are doing to help empower women and girls. It is also a way for you to speak up and shape AAUW Maryland priorities. Everyone is encouraged to attend the next AAUW Maryland meeting which will be held on October 21 in Gaithersburg. Look for details in the next AAUW Maryland newsletter!

Branch Members Meet with Maryland Attorney General Brian Frosh

On August 7, AAUW Maryland met with Maryland Attorney General Brian Frosh for a productive meeting about AAUW Maryland's Title IX delivery project and public policy agenda. Kensington-Rockville members Erin Prangley and Anna Palmisano were invited to attend. Erin, the AAUW Maryland Vice President for Public Policy, spoke about the importance of AAUW's Title IX Delivery Project in the current climate of less rigorous enforcement of Title IX on college campuses and in our K-12 schools. Anna, the founder of Marylanders for Patients Rights, asked for the Attorney General's support for the Maryland Patient's Bill of Rights. Anna and other K-R branch members have provided testimony in the past for this important legislation which would require a comprehensive, transparent, and consistent set of rights for Maryland hospital patients, whether they are admitted to the hospital or being treated in the emergency room or an outpatient clinic.

AAUW Legal Advocacy Fund: Persistence Pays Off, Saga of the Feather River Cases

Paul Thein finally has his settlement—\$2 million in May 2017. The three AAUW Legal Advocacy Fund-supported cases against Feather River Community College are closed.

Paul Thein, Laurel Wartluft, and Michelle Henley are former employees of Feather River Community College in California. In 2006, they filed whistleblower lawsuits against Feather River, alleging that the college violated <u>Title IX</u> by retaliating against them for complaining about sex discrimination, among other claims. Although their suits were filed as separate cases, all three cite related incidents in 2005. AAUW began supporting their cases in 2007.

Thein, as vice president for student services, was concerned that the college was not in Title IX compliance because the women's sports coaching staff was being treated differently from the men's sports coaches. As he probed the situation, the college ended his employment.

Wartluft had been hired on an emergency basis as head women's basketball coach and part-time faculty member. She applied for the permanent position when it was advertised and thought she had been hired because she began teaching and coaching the next academic year, but remained without contract and unpaid until her job was abruptly terminated.

Henley was investigating reports of sexual harassment of students by a college staff member, only to be warned to be careful because the alleged harasser's father was a senior faculty member. She herself was then harassed by college staff and faculty, disciplined for an action she did not commit, and quit her job in April 2006 rather than suffer more retaliation.

Thein filed suit against Feather River in August 2006; Henley and Wartluft filed similar suits in November 2006. Each plaintiff filed a whistleblower lawsuit, alleging that the college violated <u>Title IX</u> by retaliating against them for

complaining about sex discrimination, among other claims. AAUW LAF began supporting the cases in 2007.

The cases were eventually referred to California's State Personnel Board. In August 2009, a California personnel board judge issued a decision in favor of all three plaintiffs, ordering their reinstatement and awarding them back pay and damages. Feather River appealed that judge's decision. After a lengthy appeal, the full personnel board upheld the 2009 decision in the plaintiffs' favor. Henley and Wartluft settled their cases in 2015.

Civil rights laws like Title IX of the Education Amendments of 1972 do more than prohibit gender discrimination in education. Title IX also protects educators who challenge discriminatory treatment on their campuses. Too many educators who stand up for fair treatment face retaliation. The Feather River cases highlight the importance of protecting educators who do the right thing. Faculty and staff who are willing to fight for fairness on campus and in the classroom should not be terminated by colleges and universities in retaliation for their activism.
