Yun Jung Yang was appointed to the Maryland Commission for Women in October 2015 and was elected chair in June 2018. She is the Managing Partner of Law Offices of Yun Jung Yang, LLC, a Silver Spring-based boutique firm specializing in immigration law. For the past three years, she has co- chaired and chaired the Maryland Commission for Women's Voices of Maryland Women Listening Tour project and served on the Maryland Women's Hall of Fame Committee, the Women of Tomorrow Committee and the Education and Outreach Committee.



Judith Vaughan-Prather was appointed Executive Director of the Maryland Commission for Women (MCW) in July 2014. She served as Executive Director of the Montgomery County Commission for Women (CFW) for very nearly 35 years. Under her leadership, the Montgomery County CFW conducted successful projects on Single Mothers and Poverty, Educational Equity, Immigrant Women, Sexual Harassment, Pay Equity, Family Equity in the Courts, the Status of Women in Montgomery County, Work and Family Issues, Women and Girls in Technology, and Relationship Violence, among others.

AAUW Legal Advocacy Fund

An important role of AAUW's legal advocacy work is demonstrating the real-life impact of pay discrimination on people. One such person is Zoe Spencer, Ph.D., a professor of sociology at Virginia State University who is suing the university alleging wage discrimination and retaliation under the <u>Equal Pay Act of</u> <u>1963</u> (EPA) and <u>Title VII of the Civil Rights Act of 1964 (Title VII)</u>.

Spencer's Discovery Leads to an Equal Pay Fight

As the Gender Equity Task Force chair at Virginia State University (VSU), Spencer was charged with identifying deficits in gender equity, but when she did she met with resistance. Her advocacy for systemic reform unearthed a personal pay equity issue, which prompted litigation claiming wage discrimination and retaliation.

In 2014, two male administrators at VSU were appointed to faculty positions as associate professors. Spencer alleges that their salaries were vastly higher than those of female professors at all ranks and \$35,000–\$49,500 higher than her salary. She requested a salary adjustment based on Title VII and the EPA, but her request was denied. Spencer alleges that she subsequently faced retaliation, including delays in processing her pay.

AAUW provides financial support for this case through our Legal Advocacy Fund because in the <u>absence of new, comprehensive federal equal pay legislation</u>, litigation is the primary remedy for women like Spencer. We will continue to help fund her case as it travels through the judicial process.

Did You Know . . .

... that Congress in 1907 revoked the citizenship of any US woman who married a foreigner? The Expatriation Act of that year did deign to add that if her husband later became a naturalized citizen, she could petition to regain her birthright status—through the naturalization process! (The Naturalization Act of 1855 gave a foreign-born woman US citizenship if she married an American man, since her "allegiance would shift to the nation of her husband." The converse did not apply.)

Loss of citizenship could mean loss of a job, ineligibility for public assistance, or deportation. Worse, during World War I, American-born wives of German or Italian men were declared enemy aliens!

When women finally got the right to vote in 1920, they intensified their push for equal and nonderivative citizenship rights, lobbying Congress as a sizable new constituency. During a time of heated anti-immigrant feeling, some pointed out the political illogic of allowing an uneducated immigrant woman who married an American man to vote, while an educated US-born woman married to a foreigner could not.

At last, in 1922, the Cable Act, or Married Women's Independent Nationality Act, stated that a woman could keep her citizenship if she married a man who *could* become a citizen, even if he did not. However, if already expatriated, she had to undergo a burdensome process to regain her national identity. If her husband was legally ineligible for citizenship (meaning Asian at the time), she could still be denied hers—at least until he died. If she lived abroad for two years, she forfeited her birthright and could wind up stateless.

It wasn't until 1931 that amendments to the Cable Act legally recognized male and female citizenship as equal and independent in the United States of America.
