### AAUW Legislative Update: Crossover Success!

One of the big downsides of a part-time legislature is the rush to pass legislation in a mere four months. To meet this truncated schedule, Maryland legislative rules require all bills to pass at least one of the Houses by a "crossover" date in order to have the best chance of passing this session. This year several AAUW legislative priority bills met this deadline (March 18) and are on to the opposite house for a vote.

By far the biggest AAUW success is the favorable vote of the Maryland Patients' Bill of Rights (HB145/S301), which unanimously passed the House. This legislation would give hospital patients throughout the state a access to transparent, standardized, consistent set of core rights—no matter which hospital they are in, and train of all medical personnel in patient rights will raise awareness of patient rights within the hospital culture. Another great success was the advancement of legislation that would prohibit using prior salary history in employment decisions (S738/HB634). Anchoring starting wages to prior salary history leads to a lifelong pay gap. This practice causes real harm. It adds up. It takes a personal toll. This bias and discrimination is costing women and people of color (and their loved ones) the paychecks, pensions, and security that they need and deserve. Kate Campbell Stevenson, AAUW President and KR branch member, testified in Annapolis on both bills. Look for an action alert in the next few weeks urging all senators to support the bills as they move to the opposite legislative chamber.

It is disappointing that a few of our priority bills did not make the crossover date, including important legislation which would have allowed courts to extend child support orders for students over 18 years old. The legislature also failed to move the "Time to Care Act" that would have authorized the state to create a family and medical leave insurance program, similar to unemployment insurance or short-term disability insurance. Look to see these proposals again in 2020!

## Legal Advocacy Update

The Supreme Court Finally Addresses the Rizo Case ... in Part.

Aileen Rizo's Fight for Fair Pay Continues.

On August 30, 2018, Fresno County Superintendent of Schools filed a petition for appeal with the Supreme Court of the United States to challenge the decision of the U.S. Court of Appeals for the Ninth Circuit, which had found in favor of Aileen Rizo's Equal Pay Act case. The Ninth Circuit had held that using prior salary alone, as a "factor other than sex" or in combination with other factors, cannot justify a wage differential under the Equal Pay Act.

On February 25, 2019, the Supreme Court vacated and remanded the Ninth Circuit's decision, which means that they determined that the Ninth Circuit's decision was flawed. It was sent back





to the appellate court for additional review. The Court arrived at this conclusion without reviewing the merits of the equal pay case, focusing solely on the second issue before the Court, which was whether a federal court can count the vote of a judge who dies before the decision is issued. This was relevant because the judge who authored the Ninth Circuit decision died on March 29, 2018, although he had voted and issued his opinion prior to his death.

AAUW has been fighting for Rizo and others by advocating for pay equity and fairness in compensation and benefits as a means to achieve economic self-sufficiency for all women. We will continue to support her case through our legal case support program. Read her full story <u>here</u>.

#### Why Rizo Matters

Basing pay on salary history can perpetuate the pay gap because women are typically paid less than men. If an employer bases the salary of a new employee on past wages, any prior discrimination in those wages is carried forward. This domino effect perpetuates pay inequity and has an impact on a woman's economic security. Rizo's case sheds light on this important yet often unrecognized factor contributing to the pay gap.

#### It's Time to Pass the Paycheck Fairness Act!

Rizo's experience magnifies the need for strong state and federal legislation to eliminate the practice of using prior salary alone in setting current wages. Federal legislation, like the <u>Paycheck Fairness</u> <u>Act</u>, currently pending in Congress, addresses the "factor other than sex" affirmative defense of employers by requiring them to articulate a necessary, job-related justification for pay differentials. The legislation also prohibits reliance on salary history during hiring. <u>This</u> <u>legislation</u> will help close the gender pay gap and promote economic security for women nationwide. <u>Stand with AAUW and take action for Equal Pay</u>.
