# The Preference System – Who Should Legally Enter the U.S?

Sameen Ahmadnia, Esq. an associate at the law offices of Dzubow and Pilcher, will speak on the Immigration/Department of State Preference System.

Ms. Ahmadnia will discussion the Immigration Preference System as it currently works and how it might work to meet the demands of a changing economy and continue to honor our long history of humanitarian and family admissions. You will have a chance to be an Immigration Czar and rank the categories of immigrants admitted into the U.S.

Background: The Immigration Act of 1990 specifies how many legal immigrants can enter the U.S. each year (approximately 700,000 with a per-country quota) in each of specified categories: family-sponsored visas; employment based; humanitarian based (refugees and asylees) and diversity-visas. The Department of State administers the Preference System which is a method, based on the categories or "preferences" of distributing the limited number of immigrant visa numbers available each year. The only exception is immediate relatives of U.S.

citizens – spouse, minor children and parents of those 21 who are allowed to enter after being inspected. Under the current system, many individuals approved for a visa are backlogged with an average wait of 5 years and 8 months and for certain countries -- India, Mexico, China, Philippines and El Salvador/Guatemala/Honduras—the wait is much longer.

There have been several attempts over the past years to devise a new system which would admit immigrants with highly skilled occupations as well as lower-skilled occupations like agriculture, health and elder care and service-sector jobs. The current administration has proposed a system which considers labor-market needs and includes a point system which would reward employment in specialty or in-demand occupations and English ability. This system is currently used by Canada, Australia, the United Kingdom, Japan and China. Under this proposal many family-based visa holders who had been waiting for years in the backlog would never be admitted to the U.S.

### **Message from the President:**

September is always an exciting month as we transition from "summer mode" to a "more disciplined and serious" schedule.

Our branch program team is planning a stimulating year to stretch our minds and delight our spirit. Our public policy team is preparing to tackle key issues in Annapolis and on Capitol Hill. An AAUW member can easily express his or her opinion on this subject and others through the 2-minute activist which makes it extremely easy to contact your Congressional representatives.

The AAUW of Maryland consists of 13 branches and one on-line community.

Many of our branch members are active on the state level. Currently three members of our Branch are serving as officers of the State organization. Kay Campbell Stevenson is the co-president, Tracy Lanz is the Program Co- Vice President and Erin Prangley is the Public Policy Vice President. Also, several branch members including Anna Palmasano and State Senator Susan Lee, worked on the successful efforts to pass the Hospital Patient's Bill of Rights. This bill, signed into law on April 30, 2019, replaces an outdated and ineffectual law from 1978. Maryland AAUW is also working on the pay gap issue. In the 2019 legislative session, lawmakers in Annapolis did not pass S.B. 738/H.B. 634 which would have prohibited employers from relying on a job applicant's salary history to determine pay. This issue and others deserve our attention and efforts in the coming year. Take a look at the state webpage and read the quarterly newsletter, the Marylander.

The last opportunity available to all branch members is to partake of the camaraderie, knowledge, fun and caring shared within our branch. I'm looking forward to serving as your President during the coming year and hope you will explore your opportunities.

# **AAUW Joins Additional Amicus Brief Supporting Contraceptive Coverage**

The Trump administration issued rules rolling back the contraceptive mandate in the Patient Protection and Affordable Care Act (ACA) by exempting organizations with religious or moral objections. The rules were scheduled to go into effect in January 2019, but several states successfully challenged these "Final Exemption Rules" and were granted preliminary injunctions. AAUW signed onto several amicus briefs in support of those preliminary injunctions in many jurisdictions at the district and appellate court levels.
