notices. Long-timers' dues are due July 1 (payable starting April 1).



#### **Public Policy Update**

any of you will remember that earlier this year we heard a powerful branch presentation by Anna Palmisano, PhD Director of Marylanders for Patient Rights. Anna shared the abysmal metrics about quality health care in our state Nationally, Maryland has consistently been in the bottom 10% of hospital patient satisfaction, had the worst rating in ER wait time, and the second to worst in nursing home inspections. She shared with us past efforts to address this poor record, largely a result of the failure of the Maryland Office of Health Care Quality (OHCQ) to provide sufficient oversight of Maryland's health care facilities.

With new leadership of that office in place, the Marylanders for Patient Rights will be putting forward proposed legislation for a stakeholder ad-



visory council for the Maryland OHCQ for hospitals and nursing homes.

You will be hearing more about this proposed legislation in the coming months, along with the proposed legislation that will be promoted by the Maryland Legislative Agenda for Women. MLAW will hold its Fall Conference in Columbia, MD, Women in the Lead: Protecting Our Rights, on November 1<sup>st</sup>. Both AAUW Maryland and Kensington-Rockville Branch are cosponsors. #### Anna Palmisano Continues to Press for Better State Inspections of Health Care Facilities

#### **OHCO Oversight Is Needed**

The Aug. 25 Metro article "Audit finds hazards at Md.'s adult day cares" exposed the abject failure of Maryland's Office of Health Care Quality (OHCQ) to provide inspections for vulnerable adult day care attendees.

But this is just the tip of a much larger iceberg. For over a decade, OHCQ has failed to provide adequate oversight of Maryland's health care facilities. According to national rankings from the Centers for Medicare and Medicaid Services, Maryland has been consistently in the bottom 10 percent for hospital patient satisfaction, worst in emergency room wait time for almost a decade, and second-worst in nursing home inspections. And nursing home residents filed a class-action lawsuit against the Maryland Department of Health, citing many horrific examples of alleged neglect.

OHCQ needs to return to its vital function of providing active oversight of our health care

facilities to improve the declining quality of health care in Maryland. One possible solution is to create a stakeholder advisory council for OHCQ. This council would increase engagement and transparency and provide diverse perspectives to improve quality of care in Maryland. Council mem-bership would draw from stakeholders including frontline hospital workers, nursing home care workers, residents, family members and patient advocates.

An advisory council would help restore public trust and provide constructive feedback to a troubled health care agency that Marylanders rely on for oversight and protection.

Do you care if the now-fully approved Equal Rights Amendment actually gets added to the Constitution as the 28th Amendment?

Is it right that over half a century after **pay discrimination** became illegal in the United States women working full time are still paid 83 cents for every dollar earned by men?

Why are we last among developed nations to provide **paid family and medical leave** for all?

If you are feeling called to *do* something positive in these challenging times, consider joining the AAUW Lobby Corps, which has actively advocated on Capitol Hill since 1975. Member volunteers, well trained and briefed by AAUW public policy staff, visit assigned congressional offices, in pairs (newcomer with someone experienced), to promote nonpartisan progress towards a more just nation.

Training lately has been virtual, with in-person briefings in the appropriate House or Senate

cafeteria prior to the day's visits. Written position papers and talking points are emailed in advance. It's pretty easy. It's truly rewarding—well, sometimes frustrating. It always matters.

The Lobby Corps currently works just two mornings per month when Congress is in session—on Thursdays, but individual dates may vary if needed.

#### What Is Great Decisions?

What is an AAUW Great Decisions discussion Group? It is a group of interested and interesting people focused on world affairs and foreign policy based on a briefing book and video series produced annually by The Foreign Policy Association.

For instance, at our September meeting, we discussed Chapter 6 of the briefing book *The Future of NATO and European Security* after viewing the related video the evening before on zoom.

Armed with this background information, we energetically discussed wars and European history going back to the 1500s "Gun Powder Empires" and past examples of unipolar powers. We discussed the purpose of NATO, its successes and issues, its changing membership and, questions such as: Can Europe be made secure without U.S. involvement? What is the value of European states having their own strategic autonomy without any reliance on the US? And, "How would the current implementation of defense and aid to Ukraine from the U.S. and European states change if Ukraine were a part of NATO?

Participants always bring their own experiences to share, No one needs be an expert, and the monthly subjects change (e.g., India: Between China, the West, and the Global South; and American Policy in the Middle East). Most participants join together afterward in the Ingleside Café for lunch and socializing. We may not solve all the problems of the world, but we do gain new knowledge, understand the world a little better, and enjoy the good company.
